"The former Yugoslav Republic of Macedonia" Turkey Ukraine United Kingdom Strasbourg, 29.09.2006 – A delegation of the Congress of Local and Regional Authorities of the Council of Europe will observe local elections in Georgia which will take place on 5 October.

The delegation, headed by Wim Van Gelder (Netherlands, EPP/CD), will also include members of the Committee of the Regions of the European Union and of the Venice Commission.

On 3 and 4 October, the delegation will meet representatives of governmental authorities, of the Parliament and of the Central Electoral Commission, as well as leaders of the main political parties. The delegation will also meet representatives of the civil society and of the international community in Georgia, as well as domestic and other international observer organisations.

Ten teams of observers will be deployed throughout the country on Election Day. The Congress delegation will present its preliminary findings at a press conference in Tbilisi on 6 October (time to be confirmed).
