Council of Europe Secretary General Terry Davis expresses concern about the health of Kurdish hunger strikers in Strasbourg

Strasbourg, 10.05.2007 - "I have learned with great concern that some of the hunger strikers demanding that a team of independent doctors visits Abdullah Öcalan have recently been taken to hospital. I urge them to put an end to any action which can further jeopardise their health.

Some of the hunger strikers have recently met representatives of the Council of Europe. I should like to take this opportunity to repeat that the Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) of the Council of Europe is closely examining the situation regarding the detention of Abdullah Öcalan in all its aspects."
