## Council of Europe brings human rights to the playing field: discrimination, diversity and media coverage

Strasbourg, 14.11.2008 - A seminar for sports journalists and anti-discrimination specialists across Europe starts at 2 p.m. on 20 November at the European Youth Centre in Strasbourg. It is part of the Council of Europe's "Speak out against Discrimination" campaign and is supported by the Enlarged Partial Agreement on Sport (EPAS).

The seminar will provide the opportunity to scrutinise the "media perspective" of sport and discrimination and will challenge sports journalists with questions like "How can journalists contribute to a fair, more balanced coverage of competitive sports between nations?" and "What role can sports reporters play in anti-discrimination initiatives?"

Jonathan Hill, head of the UEFA Brussels office, will introduce the first of two themes: "Intercultural awareness, racism and sport," which will be followed by a discussion on intercultural dialogue and the role of journalists.

The second theme, "the media as a means to relay information on antidiscrimination initiatives in the sports world," will be introduced by Kurt Wachter, Project Coordinator for Fairplay and Football against Racism in Europe (FARE). His introduction will be followed by a presentation from Lilian Thuram, president of the foundation *Education against Racism*.

Meantime, in the *European Encounters* event also supported by the Enlarged Partial Agreement on Sport (EPAS), researchers from Finland to Austria will discuss discrimination and diversity in sport in separate meetings at the Youth Centre, also on 20 November. They will cover themes like sports and sexual discrimination and how sports can help integrate "ethnic minorities" or immigrants. On 21 November, European institutions, NGOs and other actors will focus on sport's relationship to cultural diversity and dialogue. On that day, Lilian Thuram will formally present his foundation.

A <u>reception</u> will take place at the Youth Centre on 20 November at 6.00 p.m. At 6.15 p.m., a <u>press conference</u> will follow, with Lilian Thuram, Kurt Wachter, Jonathan Hill and Gabriella Battaini-Dragoni of the Council of Europe.
