Inquiry into alleged secret detentions in Council of **Europe member states: press arrangements**

Strasbourg, 19.01.2006 - Dick Marty (Switzerland, ALDE), who is investigating allegations of secret detentions in Council of Europe member states, is due to make his interim assessment in an information memorandum to be presented to the Committee on Legal Affairs and Human Rights of the Council of Europe Parliamentary Assembly (PACE) on Tuesday 24 January 2006 in Strasbourg.

The committee will also hold an exchange of views on this topic, and on suspected abductions on European soil, and alleged illegal transport of detainees from or through Europe to countries where the persons are at risk of torture, with the following:

- Craig Murray, former United Kingdom Ambassador to Uzbekistan
- Professor Manfred Nowak, United Nations Special Rapporteur on **Torture**
- John Sifton, Human Rights Watch, New York

Representatives of the European Parliament and the European Commission are also expected to attend.

The meeting will be followed by a current affairs debate on this subject by the plenary Parliamentary Assembly (1).

TECHNICAL INFORMATION

Access to the Palais de l'Europe

Journalists should come to the main entrance of the Palais de l'Europe, which opens at 7 a.m. On presentation of a valid press card, they will be issued with a press badge.

The Press Centre is located in Room 4 on the second floor of the Palais de l'Europe. Additional working space will be temporarily available for journalists in a neighbouring room (Room 5), on Tuesday 24 January.

Internet

The plenary debate and the following press conference with Mr Marty will be available in real time on the Parliamentary Assembly's website, <u>assembly.coe.int</u>, and the Council of Europe web portal, <u>www.coe.int</u>. Later, a link to the video record of the press conference will also be available.

Radio

Real time audio of both the debate and the press conference can be recorded either from the Internet feed or in Strasbourg. Radio journalists attending the press conference (Rooms 1 and 3) should make sure they have a 3.5 mm mono jack. For the press centre (Rooms 4 and 5) they will need a 6.35 mm mono jack.

Photo

Television

Live feed

The debate and the press conference will be covered live by a multi-camera direction, and transmitted on the Telecom 2D satellite (TC2D @ 7.91° West XP 09 C14 freq DL: 11589.3 pol Y S/R 6.1113 FEC 3/4). Camera crews on the spot in Strasbourg can take the live feed from the Audiovisual Service. The press conference will almost certainly be taken live by the EBU and ENEX.
