Natural and technological risk prevention and management on the agenda of a Council of Europe ministerial conference in St Petersburg

Date: 28 September 2010

Place: St Petersburg (Russia)

Organised by the Council of Europe and the Russian Federation Ministry for Civil Defence, Emergencies and Elimination of Consequences of Natural Disasters (<u>EMERCOM</u>).

Description: At a time when it has just experienced an unprecedented heatwave and wildfires, followed by unusually heavy rainfall, Russia is due to host the next ministerial session of the Council of Europe's EUR-OPA Major Hazards Agreement.

Designed to strengthen international co-operation with a view to preventing natural disasters and responding to them more effectively, the conference will bring together ministers from around 20 European and Mediterranean countries to agree priorities in this area and adopt an action plan for 2011-2015.

The participants will discuss the impact of climate change on the frequency and intensity of natural disasters and will set out the steps to be taken to increase states' disaster resilience and preparedness. Discussion will also focus on taking account of the human factor. Two resolutions and a recommendation will be adopted at the close of the meeting.

The conference will be opened by Sergei Shoigu, Russian Federation Minister for Civil Defence, Emergencies and Elimination of Consequences of Natural Disasters. Russia will present a review of the action taken to combat the fires which hit the country this summer.

Note for editors:

- The EUR-OPA Major Hazards Agreement (1987) is a forum for co-operation in the field of major hazards involving European and southern Mediterranean countries. Its expertise covers major natural and technological disasters, including knowledge, prevention, risk management, post-crisis analysis and rehabilitation.
- It currently has 26 <u>members</u>, including three countries from the southern Mediterranean which are not Council of Europe members.
- National platforms for risk reduction have been set up in 16 countries by the Council of Europe and the United Nations in order to boost co-operation at national, European and Mediterranean level.
