### 13.00 END OF THE CONFERENCE

### Objective

The conference will discuss new perspectives on citizen participation at local level in the framework of the participatory democratic model, necessitated by the shift from citizenship-based to residence-based participation and by the growing diversity of European societies.

The objective is to identify appropriate methods and forms encouraging and enabling the engagement of all residents, regardless of their origin and legal status, in community building.

Discussions will focus in particular on the role and place of migrants and foreign residents in the local community, their contribution to community building, their political participation through representative structures such as councils of foreign residents and through their right to vote in local elections, as well as on intercultural policies and action at local level to engage migrants.

## WORKSHOP 1: "CITIZENSHIP AND THE RIGHT TO VOTE DETERMINED BY RESIDENCE: A NEW MODEL OF PARTICIPATION"

The question of foreigners' voting rights is a well-worn subject of debate in European politics but it has now taken centre stage, as cultural diversity has become an increasingly key issue in society, amounting to one of democracy's main challenges.

If the quality of democracy depends primarily on the trust that citizens place in their institutions and on their participation in the democratic process, then no integration policy can be said to have succeeded unless migrants and minorities are involved in local life. This is, moreover, the idea that the Council of Europe Convention on the Participation of Foreigners in Public Life at Local Level tries to promote, in particular through local and regional councils of foreign residents and through the right to vote in local elections.

The aim will be to investigate the link between citizenship and nationality and, more specifically, whether they are each determined entirely separately or whether other factors may figure in their realisation, thus facilitating the transition from citizenship-based to residence-based participation.

The subject also invites us to take a position on the process of integration and the idea of strengthening the European social pact by granting non-EU nationals the right to vote in local elections. Is this a decisive factor in the attempt to tackle the deficit of local democracy and social cohesion?

The local authorities have a major role to play in integrating migrants into the community as they are in the best position to take positive action to promote the process of participatory democracy. It is vital therefore that they change their way of functioning so as to encourage more citizens to get involved and to ensure that they can participate more in the decision-making process.

## WORKSHOP 2: "PARTICIPATORY DEMOCRACY IN AN INTERCULTURAL SOCIETY: CONTRIBUTION OF FOREIGN RESIDENTS TO COMMUNITY BUILDING"

Against a background of democratic deficit, economic crisis and the growing diversity of European societies, the survival of an intercultural society depends on the development of a new form of democracy, which is not restricted to voting but based on residence and intercultural exchange. Much more than this, we should be building a system based on citizens' capacity to express themselves and discuss the future of the local community.

The current challenge seems to be to link up all the aspects of democracy in a coherent manner. There is a need to guarantee greater respect for human rights through broader participation by local stakeholders while promoting education in intercultural dialogue and setting up effective inclusive policies to integrate people and restore the social fabric.

The concept of participatory democracy also raises the question of the effective participation of foreign residents in the development of the community and the place they occupy within it.

Society must interact with newcomers and gear its institutions to their needs to avoid inflaming social conflicts, which are a potential threat to local cohesion. Municipalities are the main protagonists in this process, with the potential to create an environment that is conducive to citizen participation and involvement.

Accordingly, one of the major foundation stones of participatory democracy is consistent local policies and innovative methods which make it possible to engage in a new form of active citizenship.

Our aim should be to look at how participatory democracy can be stimulated and rendered effective and how foreign residents can be more fully and successfully involved in the community's life projects.
