REPORT ON THE MONITORING BY A CLRAE DELEGATION
OF THE FIRST LOCAL ELECTIONS IN THE REPUBLIC OF MOLDOVA,
HELD ON 16 APRIL 1995

Ms BENNETT (Ireland), Mr EYMARD (France), Mr MARTINI (Italy), Mr ZAHN (Germany), Mr PRIORE (member of CLRAE Secretariat)

I. INTRODUCTION

The Council of Europe was invited by the Ministry of Foreign Affairs and the President of the Parliament of the Republic of Moldova to send an official delegation to monitor the first local elections, which were held on 16 April 1995.

For this purpose, given the local nature of the elections, the Congress of Local and Regional Authorities of Europe was called upon to send five members to attest that the elections were carried out in a proper and democratic way.

Furthermore, the monitoring task of the CLRAE delegation forms part of a much broader assessment by the CLRAE of local democracy in the Republic of Moldova.

This assessment is the subject of a specific report (CG/Bur (2) 3 rev.), where all other information concerning the political, institutional and legislative contexts of local self-government in the Republic of Moldova can be found.

II. MEETINGS PRIOR TO THE MONITORING OF THE LOCAL ELECTIONS

The observers from the Congress of Local and Regional Authorities of Europe arrived in Kisinev on Friday 14 April. The delegation comprised:

Ms BENNETT (Ireland, L), Mr EYMARD (France, R), Mr MARTINI Chairman (Italy, L), Mr ZAHN (Germany, L). Mr PAOUR (France, L) had to withdraw at the last minute because of transport problems. Mr PRIORE, member of the CLRAE Secretariat, accompanied the delegation, which embarked upon a long series of preliminary meetings as soon as it arrived.

1. Meeting with Mr BURIAN, deputy Minister for Foreign Affairs

At this meeting, the deputy Minister was able to provide the CLRAE delegation with details of how the country was divided up for administrative purposes and particularly of the politico-administrative set-up in the eastern region of Transdniestria and the southern Gagauzia region.

As far as the situation in Transdniestria was concerned, the deputy Minister reminded the observers that it had declared its independence and, with this in mind, had organised its own local elections on 26 March, and at the same time had held a referendum on the withdrawal of the Russian 14th Army from its territory.

These elections, which had been monitored by twenty observers of the Russian Duma, were not recognised by the central Moldovan authorities.

The deputy Minister explained that, as a result of these developments, the Republic of Moldova was unable to hold its local elections on the territory of Transdniestria, with the sole possible exception of the election of the local organs of those districts also covering part of Transdniestria, ie Camenca, Dubasari and Slobosia, whose capital lies on "Moldovan" territory.

Conversely, as regards the smaller administrative units such as the towns and villages lying to the east of the river Dniestr, the Moldovan Government was obliged to refrain from exercising its national sovereignty in order to avoid diplomatic or even military incidents.

On the other hand, Mr BURIAN assured the observers that the local elections would go ahead as normal in the Gagauzia region and that at the end of May, regional elections would be held in those towns and villages on Gagauzian territory which had decided to join this special-status region in the referendum on 5 March 1995.

2. Meeting with Mr BULGARI, deputy Prime Minister, responsible for local affairs

On the basis of the Local Elections Act, the CLRAE delegation's main concern was to be assured by the deputy Prime Minister that the principle of equal opportunities for political parties fielding candidates in the election had been respected during the election campaign. Mr BULGARI explained that the government had made available to the political parties for their election campaigns a fund administered by the Central Election Committee which ensured complete transparency and impartiality in the way the fund was distributed.

3. Meeting with the political parties

Representatives of the following political groups were present at this meeting:

- Election bloc "Democratic Alliance";
- Communist Party
- Social Democratic Party of Moldova
- Election bloc between the Socialist Party of Moldova and the Movement for Equal Rights;
- Party for the economic rebirth of Moldova
- National League of Youth of Moldova
- Association of Women of Moldova
- Agrarian Democratic Party of Moldova.

This meeting took place in a room at the governmental palace. After briefly describing the purpose of its visit, the CLRAE delegation asked the representatives of all political groups for their views on the laws governing local administration. At this point, the CLRAE delegation became aware of a very critical attitude among the representatives of opposition parties towards current legislation concerning local self-government, which was described as "unconstitutional, undemocratic and contrary to the basic principles of local self-government". The representatives of the pro-government parties did not wish to respond.

When the subject of equality in the matter of election propaganda was raised, the discussion became even more heated as the representatives of opposition parties gave examples showing the government's undemocratic attitude in this respect. The delegation noted the following examples:

- widespread control of the media;
- inequality in the assignment of television broadcasting time and deliberate engineering of power cuts to prevent the broadcasting of the opposition parties' television programmes;
- public meetings disrupted by local power cuts compelling opposition speakers to hold party meetings in the dark, without loudspeakers or in the open air;
- official (state-owned) newspapers publishing the lists of pro-government parties across several pages and relegating the opposition parties to half of the last page;
- physical threats to opposition leaders' families;
- extra funding for pro-government parties in addition to the budget administered by the Central Election Committee.

The observers received the impression that the facts described, many of which were corroborated by written evidence, could be true.

4. Meeting with a parliamentary delegation

The CLRAE observers were welcomed by the Vice President of the parliament, Mr ANDRONIC.

Parliamentarians from both pro-government and opposition parties took part in the meeting.

The latter described the main problems encountered in imposing standards on local self-government.

Given the fact that all parliamentary political groups were represented at the meeting, the CLRAE delegation was able to see the different ways in which pro-government parliamentarians and opposition parliamentarians described the same problems.

The main argument used by the pro-government parliamentarians to counter the criticisms of the opposition parliamentarians seemed to comprise the problems of the period of transition from a totalitarian regime to a democratic system and the need to introduce structural reforms gradually and prudently so they would not disrupt law and order in the country.

Hence the pro-government parties describe legislation on local administration, despite all its shortcomings, as the best compromise. The observers noted that the pro-government parliamentarians intended to modify these laws as soon as the socio-political situation allowed.

The opposition parliamentarians, however, somewhat inhibited by the unusual nature of the discussion, intimated to the CLRAE observers their fear that Moldova might be governed once again by an undemocratic, totalitarian regime.

5. Meeting with the Central Election Committee

This meeting was attended by all accredited observers for the local elections of 16 April (representatives of the OSCE, Bulgarian and Romanian parliamentarians as well as Norwegian and American officials and members of the Swiss and Dutch military), members of the press and Moldovan and Romanian television journalists.

The Central Election Committee described the standards laid down in the Local Elections Act, concentrating mainly on the following matters:

- membership of election committees;
- administration of the election campaign budget;
- protection of minority languages;
- informing the public about the voting procedures and the organs to be elected;
- security during the poll and the counting of votes;
- presentation of the electoral register and the parties fielding candidates in the election;
- equal access to the media;
- number of organs to be elected, of seats and of candidates standing for election.

Based on the explanations of the Central Election Committee, the observers noted the following:

- the local organs which were to be elected on 16 April were: village councils, town councils, "communal" councils (associations of villages), municipal councils (cities) and district councils (elected by direct universal suffrage under the system of proportional representation);
- mayors of towns and villages (elected by direct universal suffrage using the single-round uninominal method);
- mayors of municipalities and presidents of districts (elected from within the council on a proposal by the government and, in the event of disagreement within the council, appointed by the President of the Republic, again on a proposal by the government);
- collegial organs (municipal boards and district executive committees) were elected from within the councils concerned in line with the political majority on the council.

The electors would have to elect two municipal councils, 37 district councils, 51 town councils, 852 village councils (totalling 942) and 903 mayors (towns and villages).

- Ballot papers would be printed in several languages and electors would be free to choose the language they preferred;
- the system of additional registers designed to palliate the old Soviet system of residence visas ("propiska") which had prevented people from voting if they had changed their place of residence two weeks before the poll. In this case, electors would now be able to vote in their new place of residence provided that they were issued with a certificate to the effect that they had changed their place of residence and been struck off the electoral register for their previous place of residence.

During the meeting with the Central Election Committee, a journalist and Mr MATEI, a current member of the opposition in the Moldovan parliament, brought to the Committee's attention a matter which, if true, could be considered very serious.

The CLRAE delegation saw Mr MATEI:

- show the judges who made up the Central Election Committee a falsified leaflet purporting to contain a call by the Democratic Alliance for Moldova and Romania to merge;
- categorically refute the authenticity of this leaflet and implicitly accuse the Agrarian Democratic Party (which held an absolute majority in the parliament) of having produced it in order to create an irreversible loss of support among the electorate for the parties of the Democratic Alliance;

- back up his argument by stating that a lack of technical and financial resources would have made it impossible for the opposition parties to print such a large number of leaflets.

Furthermore, Mr MATEI drew the observers' attention to the fact that when the Democratic Alliance had asked to denounce the falsified leaflets on television, they had been denied access to all international programmes.

He concluded by producing the leaflets in question, as evidence. The CLRAE delegation took a number of copies.

6. Meeting with delegations from other international organisations involved in monitoring the local elections

This meeting had been prepared by the OSCE representatives and was designed to co-ordinate the work of the various delegations. This enabled the observers to be spread more evenly around the country during the elections. With this in mind, the Council of Europe delegation wished to be assigned to areas not yet "covered" by other teams of international observers.

It was accordingly decided that Ms BENNETT and Mr ZAHN would cover eastern Gagauzia, that Mr EYMARD and Mr PRIORE would visit the polling stations in the central-northern part of the country and that Mr MARTINI would join Mr FONTANA, the OSCE observer, and Ms SCHROEDER, German MEP.

III. MONITORING OF THE LOCAL ELECTIONS

The CLRAE delegation was able to visit 45 polling stations spread across the whole of Moldova and can testify to what it observed directly; any kind of generalisation should be viewed with caution.

Having monitored the voting, which took place between 7 am and 8 pm, the CLRAE delegation had the impression that the elections had been on the whole well conducted.

The CLRAE observers noted in particular the efficient organisation of the polling stations, even during the counting of votes.

The electors were able to vote freely and no form of intimidation was identified by the Council of Europe observers.

The CLRAE members were in most cases given a cordial and co-operative reception.

On the other hand, the most significant weaknesses were:

- the system of the additional register of voters;

- the procedure for appointing the members of the local election committees (political appointment);
- election propaganda, even inside the polling stations;
- the presence of the police in and around some polling stations;
- the inhabitants' widespread practice of entering the polling booth in a group (family voting);
- the lack of sufficient information on the elections and voting procedures and the confusion between ballot papers;
- the long queues which formed at the polling booths.

As regards weaknesses prior to actual voting, attention is drawn to the previous chapters of this report and to the report on local democracy in the Republic of Moldova (CG/Bur (2) 3 rev.).

IV. MEETINGS AFTER THE ELECTIONS

1. Meeting with the Central Election Committee

At this meeting, the committee gave unofficial information about the turnout at the polls. This information suggested to the delegation that in Kisinev, Bender, Varnita and maybe in some other localities, where the turnout had been less than 50% of electors on the constituency electoral register, a new vote would have to be taken two weeks later with the same candidates and using the same electoral register. If the quorum of 50% of electors were not reached at the second vote, a local executive body would be appointed by the President of the Republic.

At this meeting with the Central Election Committee, the CLRAE delegation did not give an official opinion on the elections and requested that the press should not be present at the meeting.

However, before leaving Moldova, the delegation drafted the following press release:

"The delegation from the Council of Europe's Congress of Local and Regional Authorities of Europe, comprising Ms BENNETT (Ireland), Mr EYMARD (France), Mr MARTINI (Italy), Mr ZAHN (Germany) and Mr PRIORE (member of the CLRAE Secretariat), has completed its task of monitoring the local elections which took place in the Republic of Moldova on 16 April 1995.

Using information obtained in the country prior to the elections and having visited a number of polling stations spread across the country on the day of the elections, the Council of Europe delegation noted that, in spite of noteworthy attempts to ensure the local elections were run democratically, there remain difficulties in the transition from a

totalitarian regime to a democratic state based on the principles of keeping citizens fully informed in an unbiased way and of equal opportunities for the political parties involved in the election campaign."

VI. FINAL RESULTS

The results of the first local elections, which appear in the Appendix, show that on 16 April 1995, 941 councils and 902 mayors were democratically elected.

In the election of mayors of villages, towns, districts and municipalities, 1,195,707 electors voted, from a total of 1,877,267 registered voters.

In the election of municipal and district councils, 1,427,865 electors voted, from a total of 2,379,103 registered voters.

In the election of town and village councils, 1,285,962 electors voted, from a total of 1,871,583 registered voters.

The Agrarian Democratic Party, currently in government, received an absolute majority of votes (61.36% of seats in town and village councils, 50.95% in municipal and district councils, and 64.65% of town and village mayors).
