4. Terms of reference:

Having regard to:

- the Declaration and the Action Plan of the Third Summit of Heads of State and government of the Council of Europe which lays down, among the principal tasks of the Council of Europe, the strengthening of democracy, good governance and the rule of law, by taking, amongst others, the necessary steps to implement the Budapest Agenda for delivering good local and regional governance, which lists, inter alia, the challenges and actions in the area of democratic participation and public ethics at local and regional level (Paragraph I.3. of the Action Plan and Budapest/Valencia Agenda);
- Resolution Res (2005)47 on committees and subordinate bodies, their terms of reference and working methods;

The Committee, under the authority of the European Committee on Local and Regional Democracy (CDLR), and in relation with the implementation of project 2008/DGDPA/1397 "Sound institutional framework for local and regional democracy" of the Programme of Activities, and bearing in mind the criteria developed in document CM(2006)101 final, is instructed to:

Assist the CDLR in the implementation of all activities relating to governance, public management, finance and resources at local and regional level.

5. Membership of the Committee:

5.A. Members:

Governments of member States are entitled to appoint representatives of the highest possible rank and with particular work experience in the fields of competence of the committee and in the light of the items appearing on its agenda.

The Council of Europe budget will bear the travel and subsistence expenses for one representative for each of the following 17 member States: Czech Republic, Denmark, Estonia, Finland, France, Italy, Luxembourg, Malta, Moldova, Montenegro, Netherlands, Norway, Poland, Portugal, Russian Federation, "the former Yugoslav Republic of Macedonia", United Kingdom.

5.B. Participants:

- (i) The Congress of Local and Regional Authorities of the Council of Europe may send representatives to meetings of the Committee, at the charge of its administrative budget and without the right to vote;
- (ii) The Conference of INGOs of the Council of Europe may send representatives to meetings of the Committee, without the right to vote or defrayal of expenses.

5.C. Other participants:

(i) The European Commission may send representatives to meetings of the Committee, without the right to vote or defrayal of expenses;
