## 26.11.2010 Constitutional situation in Ukraine - Venice Commission's visit in the framework of the forthcoming opinion

Dates: 29-30 November 2010

Place: Kiev, Ukraine

Organised by the Venice Commission, the Council of Europe's Office in Ukraine and the Ministry of Foreign Affairs.

Description: On 30 September 2010, the Constitutional Court of Ukraine declared the Law on Amendments to the Constitution of Ukraine adopted on 8 December 2004 unconstitutional and required that laws subsequently adopted be brought in line with the 1996 Constitution.

In October 2010, the Monitoring Committee of the Parliamentary Assembly asked the Venice Commission to give its opinion:

- on the constitutional situation in Ukraine following the Constitutional Court's decision of 1 October 2010.
- on the measures to be taken to bring the new constitutional framework in line with European standards and norms.

The Venice Commission's assessment does not aim to reopen or comment on the Constitutional Court's decision, but to examine its consequences. The draft opinion on the constitutional situation in Ukraine will be discussed and should be submitted for adoption by the Commission at its plenary session on 17-18 December 2010.

In order to obtain more information on the process of bringing legislation in line with the 1996 Constitution and on the future constitutional developments in the country, a delegation of the Venice Commission will be travelling to Kiev to meet with the representatives of the Ukrainian authorities on 29-30 November 2010.

### **Background**

- Opinion on the procedure of amending the Constitution of Ukraine (adopted in October 2004 CDL-AD(2004)030);
- Opinion on the amendments to the Constitution of Ukraine adopted on 8 December 2004, (adopted by the Commission in June 2005 CDL-AD(2005)015).
