- 1) The Strasbourg CRE sent a **draft text** to the other French CREs in July.
- 2) The French CREs were asked to send their proposed **amendments** to the Strasbourg CRE by 24 September at the latest.
- 3) The Strasbourg CRE will amend the proposed text and send it back to the delegations by early October. (In principle each delegation will have received the amended text before the beginning of the Conference.)
- 4) A decision-making procedure will be adopted ahead of the Conference in the event that it is impossible for participants to reach an agreement.
- 5) The **Strasbourg CRE will produce the Statutes** of the Network and **disseminate** them to members of the Network
- 6) Adoption of the Statutes of the National Network by the delegations of the French CREs present at the Conference.
