PROMOTING CITIZEN PARTICIPATION IN ARMENIA

Background

'Strengthening local elected representatives' leadership' is a programme implemented by the Congress of Local and Regional Authorities in the framework of the Council of Europe project 'Support to consolidating local democracy in Armenia'. The project is part of the Council of Europe Action Plan for Armenia and is funded by the Government of Denmark. The programme is aimed at improving local political governance in Armenia, strengthening leadership capacities and nurturing confidence and trust in local authorities, generating a spirit of co-operation, horizontally and vertically, among local elected representatives and with central authorities.

Council of Europe and citizen participation in Armenia at local level

Armenia became a member of the Council of Europe in 2001 while signing, among other documents, the European Charter of Local Self-Government (CETS No. 122), which entered into force on 1 May 2002. On 13 May 2013 Armenia ratified the Additional Protocol to the European Charter of Local Self-Government on the right to participate in the affairs of a local authority (Utrecht, 2009, CETS No. 207). The provisions of the Additional Protocol became part of the Armenian legislation (RA Law on local self-government) on 19 June 2013. On 26 March 2014 the Congress of Local and Regional Authorities of the Council of Europe adopted Recommendation 351(2014)¹ on the state of local democracy in Armenia, which, inter alia, recommends Armenian authorities to apply instruments promoting citizen participation at local level, and to seek opportunities to stimulate local residents' interest in their work and achievements. In order to assist communities to put into practice the aforementioned provisions and recommendations, the Congress has developed several initiatives, including two Regional Seminars. Moreover, the Congress is currently supporting 4 Armenian communities to implement pilot citizen participation initiatives, which may become replicable for other local governments in Armenia.

The regional seminars

The purpose of the regional seminars is to enhance the level of citizen participation in the decision-making at local level in Armenia. During the opening plenary session the local and international organizations and experts will present tools and best practices of citizen participation at local level, including the pilot citizen participation initiatives supported by the Council of Europe. In group sessions, the participants will discuss participatory budgeting at local level, the role of municipal councillors and civil society in promoting the participation of citizens in the decision making process, and the role that can be played by information and communication technologies. On the basis of the tools and initiatives presented and discussed during the regional seminars, "Citizen participation guidelines" will be developed and disseminated to participants and other interested parties.
